Historical Note

The two-court system inherited from North Carolina was continued in Tennessee under the first state constitution of 1796. The lower court was the Court of Pleas and Quarter Sessions (County Court). For more on it, see Record Group 5: County Court Records. The higher court, which heard cases on appeal, as well as more serious criminal cases and case involving equity, was known as the Superior Court of Law and Equity. For more on it, see Record Group 18: Superior Court of Law and Equity. By the early 1800s, the court system was becoming overworked. A state Court of Equity was established that was held with three traveling judges hearing cases in five judicial districts established for Tennessee. That for the Washington District was held in Jonesborough. The additional districts were Hamilton District (held at Knoxville), Mero District (held at Nashville), Winchester District (held at Carthage), and Robertson District (held at Clarksville). This court evolved into the Supreme Court of Errors and Appeals, which, in turn, evolved into the Tennessee State Supreme Court. The court heard larger equity cases and cases appealed from lower Tennessee courts. Court was held in various parts of the state, including Jonesborough. Judges of these courts included David Campbell, John Overton, Hugh L. White, and Andrew Jackson.

Scope and Content Note

The record group contains court records related to actions of Tennessee's Court of Equity and the Tennessee Supreme Court of Errors and Appeals during the first third of the 19th Century, when cases were heard for the First Judicial Circuit in Jonesborough. Because the court at Jonesborough had jurisdiction over area counties other than just Washington County, researchers should check the records for other upper East Tennessee counties during the antebellum period.

All cases are appeals of cases from lower Tennessee courts, including Circuit Court and Chancery Court. Document types include case transcripts, depositions, correspondence, minute books, case enrollment records, an order book, an index to enrolled cases, bills of costs, among other items. Many types of civil and criminal cases are included dealing with such matters as land and estate disputes, divorce, debt, murders, among much else. Issues such as slavery, the Civil War, domestic relations, and other social and cultural aspects of Tennessee life are revealed in these cases.

Sub-Group Description

The records for the Tennessee Supreme Court of Errors and Appeals (Jonesborough) contain miscellaneous court documents in various cases between 1830 and 1835. Documents include bills of costs, injunctions, writs, court orders, etc. These records were originally part of the Washington County Court Records transferred to East Tennessee State University in 1958 and later separated into its own manuscript collection (accession 173). After the return of the records to the Washington County Archives in August 2016, these papers were incorporated into Record Group 24.

Series Description

The series of administrative records consists of one document in which Seth Lucky, clerk of the court, acknowledges the revenue he has collected in his office. In the same document, Daniel Barkley and William P. Chester, justices of the peace, make their report of having inspected the books, papers, and records of the court on December 28, 1830.

Series Description

Series B consists of files to court cases heard by the Supreme Court in Jonesborough between 1832 and 1835, when Jonesborough served as a site on the court's judicial circuit. The cases are arranged in chronological order. Documents include summons, deposition, case transcripts, bills of costs, etc. Researchers will find cases from Washington County and other upper East Tennessee counties included in the series. A total of 64 cases are included in the collection. Note: Records for 21 selected cases that originated in Chancery Court and Circuit Court for Washington County and that were later appealed and heard by the Tennessee State Supreme Court have been copied from original Supreme Court case files held at the Tennessee State Library and Archives in Nashville.

Series Description

The minute book for the court covers the period June 1830 through July 1835. Cases and actions of the court are summarized. The cases were those held during this period when the Supreme Court made a circuit in Tennessee and met periodically in Jonesborough. The clerk was Seth J. W. Lucky. When Chancery Court was established in Washington County in 1836, Lucky became the first clerk and master and apparently continued using the back half of the volume as a rule docket for Chancery Court. The volume is housed in Record Group 4, Clerk and Master Records.
