

## BLACKSTON McDANDEL COLLECTION

**Provenance:** This collection of personal papers was found among county records returned from the Paul Fink Collection to the archives by the McClung Historical Collection, Knoxville, Tenn., on August 26, 2019. In July 2020, the papers were processed as a separate manuscript collection.

**Access Note:** The papers are available for research use.

**Biographical Note:** Blackston McDannel, sometimes spelled McDonald, was born January 15, 1811, probably in Knox County, Tennessee. His parents were John McDannel and Sally Whitson. McDannel married Elizabeth Britton in Greene County on Oct. 28, 1830, and had two sons, James and John. Elizabeth (born 1811) died in 1848, and McDannel married Louisa Britton in 1854. He traveled widely in the southeast doing plastering work. During the Mexican-American War, he was a clerk with the army's Quartermaster's Corps. In 1861, he was appointed U. S. Marshal for East Tennessee in Greeneville, where he was a friend and political supporter of Andrew Johnson. Blackston McDannel died on July 27, 1888.

**Scope and Content Note:** The collection consists of personal correspondence, receipts, financial records, and notes documenting Blackston McDannel's life and his career as a United States Marshal in East Tennessee during and following the Civil War. Documents are arranged in chronological order. Two oversized documents are housed in a map folder and stored in the map cabinet by accession number.
