Provenance: This collection of personal papers was found among county records returned from the Paul Fink Collection to the archives by the McClung Historical Collection, Knoxville, Tenn., on August 26, 2019. In July 2020, the papers were processed as a separate manuscript collection.

Access Note: The papers are available for research use.

Biographical Note: Josiah Conley was born November 30, 1804 in Washington County, Tennessee, the son of John Conley and Agnes Stuart. He married Mary Ann Allison on August 4, 1829 in Washington County, and they were the parents of nine children. Mary Ann died in 1852, and Josiah died on December 7, 1865. He is buried in the Fairview Cemetery in Washington County.

Scope and Content Note: The collection consists of personal letters, receipts, notes and accounts documenting the life of Josiah Conley. The collection is arranged alphabetically by document type and then chronologically.

Warrant for the arrest of the three defendants, who are accused of stabbing and mortally wounding a “fine bull, the property of s^d Conley...”, July 19, 1853. The original document was removed to Circuit Court case files, RG3.B, 1853: State vs. Skelton McCray, Kit M. Genny (alias Taylor) and Jink Taylor, a man of color, the slave of Henry Taylor.
