

## CARMICHAEL FAMILY COLLECTION

**Provenance:** This collection of personal papers was found among county records returned from the Paul Fink Collection to the archives by the McClung Historical Collection, Knoxville, Tenn., on August 26, 2019. In July 2020, the papers were processed as a separate manuscript collection.

**Access Note:** The papers are available for research use.

**Biographical Note:** William Carmichael was born near Leesburg in Washington County on May 8, 1792, the son of Archibald and Isabel Pomeroy Carmichael. He married Patsy Martha Blair (also born in Washington County.) William died in April 8, 1841 in Washington County and is buried at Fairview Cemetery. After William's death, Patsy moved to Jackson County, Missouri, where she died in 1854.

Dr. Archibald Carmichael was born March 16, 1818, the son of John Carmichael and Isabella and lived the majority of his life in Hawkins County, where he was a practicing physician. He married Rachel Jane Parks in 1843 in Greene County, Tennessee. They were the parents of six children. Both Archibald and Rachel Jane are buried in the New Presbyterian Churchyard in Rogersville.

**Scope and Content Note:** The collection consists of Carmichael family correspondence and helps document their life in 19<sup>th</sup> century East Tennessee. Several letters deal with the administration of William Carmichael's estate as handled by Dr. Archibald Carmichael and John Blair. Some letters concern a failed attempt to purchase a mill. The letters are arranged in chronological order with undated letters filed at the end of the collection.
