PHILLIP SHELLY LOST TO HISTORY FOR OVER 135 YEARS

There is a saying, "Don't make an archivist mad; they can erase you from history." We have officially proven that this can be true. On December 4, 2024, we corrected a mistake that was made back in the late 1880s and hopefully, righted a wrong.

This story begins when the archives was contacted by a gentleman in Arizona who wished to return a document to our possession. It was a warrant for the arrest of Phillip Shelly, for a "trespass" on Samuel Tate. The document was dated 1778, and was one of the earliest court cases to come before the newly-formed county court, and signed by John Sevier, the first clerk of the court, and later, the first governor of the state.

The original arrived in our office on December 3, and in the morning hours of December 4, Ned and I began the accession process in earnest. We were interested in knowing the order in which the case was heard in the court, and we pulled the County Court Minute Book 1, and the WPA's index. There were several entries for Samuel Tate, but not one for Phillip Shelly. How could that be? He had to be there...it was then that Ned realized that it had been incorrectly transcribed as Phillip SHELBY! The mistake changed his name...until today.

To give a little bit of a back story, our original copies of the County Clerk Minute books were taken to Nashville in 1886 for the Tennessee Historical Society to preserve and protect. In return, they were to provide the county with a written transcription. If you have ever looked at County Court Minute Book 1, it is obvious that it's not the original, which was written beginning in 1778, when the first county court was organized.

The THS provided the transcribed copy and it is on our shelves in the archives. I have looked at this book many times in the past twenty-five years, and often marveled at the accuracy of the transcription.

Today we made a note in the county minute book and the WPA's index that the name is SHELLY, not SHELBY.

Phillip Shelly was listed on the 1778 listing of the taxables in the Sheriff's Report to court, shown below:



We found that our archives' volunteers had correctly listed his name as SHELLY, and when a search was done through our court case files, we found that there were several cases involving him. An attempt to gather further genealogical and historical information was not successful and Shelly disappears from the county records in 1784.
